### egulations

#### Thai cosmetics labeling requirements

A label for all cosmetic products must indicate the necessary contents as follows:

- 1) Name of product and trade name of product, which must be larger than other contents
- 2) Category or type of cosmetics (such as shampoo, conditioner, etc.)
- 3) Full ingredient list from high to low percentage
- 4) Directions of use
- Name and address of manufacturer (for local product) or name and country of manufacturer (for imported product)
- 6) Net content in metric (ml or g)
- 7) Manufacturing month and year or manufacturing year and month, and batch number
- 8) Expiry date (for product with shelf-life less than 30 months)
- 9) Warning (in accordance with the Ministry of Public Health Notification)
- 10) Notification number

In case of small container which has label-showing space of less than 20 square centimeters, at least the contents in no. 1, 7 and 10 must be shown, and other necessary contents shall also be shown on the insert.
